**TO THE SUPREME COURT OF THE STATE OF NEW YORK:**

Kevin Eric Saunders, a.k.a. bonze blayk and bonze Anne Rose Blayk, respectfully shows to this Court the following:

1. My present address is 1668 Trumansburg Rd., Ithaca, NY, 14850, in the Town of Ulysses, County of Tompkins. My telephone number is (607) 277-5808.
2. I was born on May 1, 1956 in Little Rock, Arkansas, and I am now 55 years of age.
3. I wish to change my name to Bonze Anne Rose Blayk.
4. I am a natural-born citizen of the United States of America.
5. I am divorced.
6. I have never been convicted of a crime. (An NGRI plea was entered and accepted on July 28, 1997 in case 1997-0019 by the County Court of Tompkins County.)
7. I have never declared bankruptcy, and I have never been adjudicated a bankrupt.
8. There exists one judgment against me. The details are as follows: Entered July 25, 1997: Susan Hamann, \$75,000; Simonetta Antenucci, \$14,500.
9. I may soon become a party to a legal action, lawsuit, or legal proceeding, since I may be filing for the eviction of Alice H. Richardson from my home (where she has not resided for over two and a half years) so that I may legally remove her belongings from the premises.
10. I do not have support obligations to a child or children.
11. I am not responsible for spousal support.

12. I wish to change my name for the following reason(s):  
 I wish to change my name to the AKA I have uniformly used in conjunction with my legal name since 1992; I am transitioning from male to female in order to bring my sex into accordance with the fixed and stable gender identity I have had since childhood, and am preparing to undergo sexual reassignment surgery when funds become available to me for this purpose.
13. I have not made a previous application to change my name in this or any other court.

WHEREFORE, Petitioner respectfully asks for an order permitting him to assume the name Bonze Anne Rose Blayk.

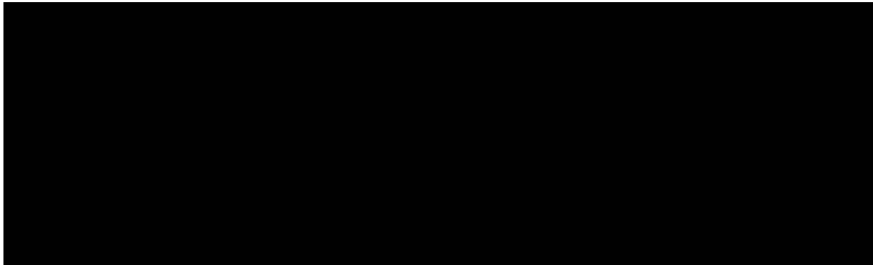

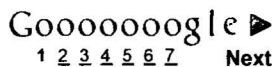

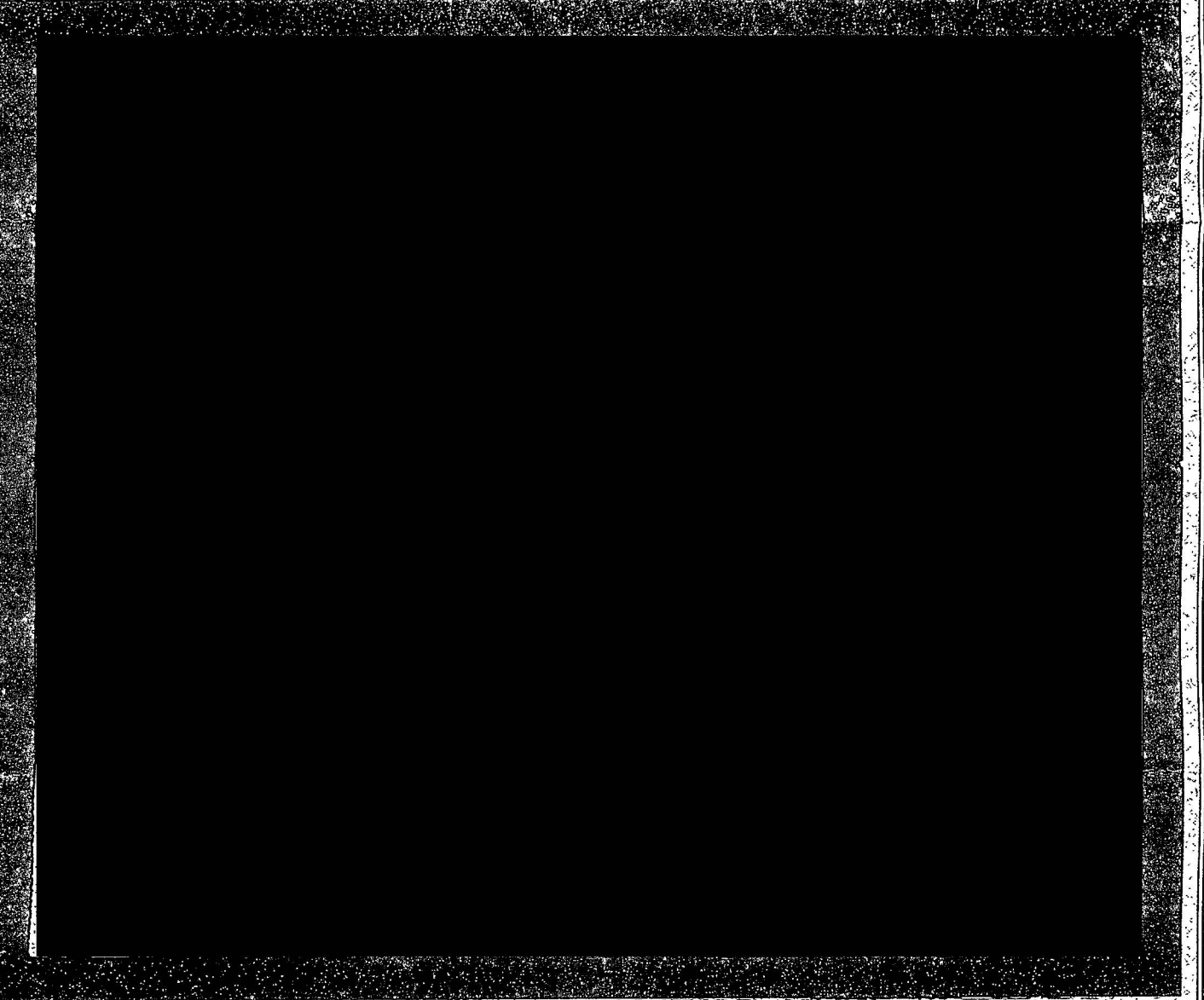

I saw you today for a psychiatric assessment; you told me of your wishes to proceed with legally changing your name to "Bonze Anne Rose Blayk". I have been seeing you since 2007 in this clinic. Upon examination today you had no major psychiatric diagnosis. You have been talking to me about transgender issues for an extended period of time and have also talked of wishing to change your name in the past.

In my opinion, with a reasonable degree of medical certainty, you have capacity to petition the court for a legal change of name.
